#### DECLARATION

To be read and signed by the Students & Father / Guardian.

- 1. The entries made in the application form are correct and no alterations of any kind shall be hereafter asked for.
- 2. I have throughly gone through and read the Rules and Regulations of the CESD as mentioned in the prospectus purchase by me from the office of the CESD and understood the same, having varified the bonafides and the performance of the CESD and being fully satisfied, I am seeking admission to the CESD voluntarily.
- 3. I have clearly understood and noted that the fee charges once deposited by me shall not be refunded/adjusted in any case and neither I shall claim any refund nor I shall approach any court of law for refund of my all deposits of fee, charges.
- 4. I agree to pay the balance installments as communicated.
- 5. If my attendance will be below 75%, I shall not be entitled to appear in examination and shall not challenge / approach / appeal to any court of law.
- 6. The candidate may give the option for the course while filling the practical university/organisation according to date sheet framed by university / organisation.
